Terms of use

Milbon Co., Ltd. (hereinafter referred to as "Milbon") has described a set of terms for access and use (hereinafter "Terms of Use") of the websites it operates (hereinafter "Websites"). Users are asked to agree to these conditions before use. By using the Websites, you agree to be bound by these Terms of Use. Milbon reserves the right to change these Terms of Use as necessary. Please regularly check this document and ensure you are aware of the latest information herein.

Article 1 (Use of the Websites)

The user shall prepare an appropriate device and communication environment to use the Websites at the user's expense and responsibility.

Article 2 (Intellectual Property Rights, etc.)

- 1 Copyrights, trademark rights, design rights, portrait rights, and other moral or property rights (hereinafter referred to as "Intellectual Property Rights") for content provided by Milbon on the Websites (including text, images, video, audio, programs, and other information; hereinafter collectively referred to as "Content") shall be reserved by Milbon or the appropriate third party. - 3 Users may not use any trademark (including trademarks, service marks, brand names) found in the Content without prior written permission from Milbon.

Article 3 (Prohibited Behaviors)

Milbon prohibits any of the following activities related to use of the Websites.

- 1 Any action that infringes or may infringe upon the Intellectual Property Rights or other property rights or privacy of Milbon, other users, or third parties.
- 2 Any action that constitutes or may lead to defamation or libel of Milbon, other users, or third parties. Criminal acts or any action that may lead to crimes through use of the Websites.
- 3 Any action that is offensive to public order and/or morals, in violation of laws, or may constitute these through use of the Websites.
- 4 Any action that damages or undermines the reputation of Milbon or the Websites.
- 5 Any action that interferes with the operation of Milbon or the Websites.
- 6 Unauthorized access, or transmission or dissemination of harmful programs, such as computer viruses, to Milbon or any third party, or any act that encourages such acts.

- 7 Any action that violates these Terms of Use.
- 8 Any other actions that Milbon reasonably deems inappropriate.

Article 4 (Suspension or Discontinuation of Website Provision)

Milbon reserves the right to suspend or discontinue provision of the Websites, in whole or in part, without prior notice to users in any of the following cases. In such an event, Milbon shall not be liable for any resulting damage, loss, or disadvantage caused to the user.

- 1 In the event of unavoidable circumstances related to the maintenance of systems or other elements of the Websites' provision.
- 2 In the event that the provision of the Websites becomes unreasonably difficult due to natural disasters such as fire, earthquake, or flooding, or due to force majeure such as civil disturbance, terrorism, or rioting.
- 3 In the event that the provision of the Websites becomes unreasonably difficult due to system failure or unauthorized access from a third party.
- 4 In any other event where there is a reasonable necessity to suspend or discontinue the provision of the Websites.

Article 5 (Disclaimer of Liability and Indemnification of Damages)

- 1 Users shall use the Websites at their own risk, and shall retain full responsibility for any and all actions they take on the Websites, as well as for the outcomes of use of information, etc., provided on the Websites.
- 2 Milbon disclaims any and all liability for damages arising from access to or use of the Websites, their suspension or discontinuation, or changes in their contents, nor for accidents or impediment with regard to software or hardware arising from access to or use of the Websites.
- 3 While Milbon makes every effort to ensure that the Websites and the Content are appropriate, Milbon does not guarantee their fitness for purpose, functionality, safety, reliability, accuracy, certainty, timeliness, or completeness.
- 4 Milbon provides no guarantee regarding the content of third party websites, etc., that are not under the control of Milbon, even if they are linked from the Websites. 2 Personal information entered into the inquiry form will be stored in Japan. Please note that if you use the inquiry form from outside Japan, your personal information will be sent to Japan. Depending on the content of your inquiry, the person in charge at our overseas subsidiaries or representative offices may respond to your inquiry. For this reason, we may provide the information entered in the inquiry form to our overseas subsidiaries and representative offices. Please refer to our Privacy Policy for information on who is responsible for the protection of personal information and where to submit inquiries.

Article 7 (Notification and Modification of Terms)

Any changes to these Terms of Use or other communications from Milbon to users regarding the Websites shall be posted in appropriate locations on the Websites or by other means deemed appropriate by Milbon.

Article 8 (Governing Law and Jurisdiction)

These Terms of Use shall be governed by and interpreted in accordance with the laws of Japan, and any dispute filed arising out of or in connection with these Terms of Use shall be under the exclusive jurisdiction of the Tokyo District Court in the first instance.
